This third supplement (the "**Third Supplement**") constitutes a supplement to and must be read in conjunction with the Base Prospectus dated 12 July 2022 granted approval number 22-297 on 12 July 2022 by the *Autorité des marchés financiers* (the "**AMF**") as supplemented by the first supplement dated 30 August 2022 granted approval number 22-363 on 30 August 2022 and the second supplement dated 5 October 2022 granted approval number 22-411 on 5 October 2022 (together, the "**Base Prospectus**") prepared by Vinci (the "**Issuer**") with respect to the Euro 12,000,000,000 Euro Medium Term Note Programme (the "**Programme**"). Terms defined in the Base Prospectus have the same meaning when used in this Third Supplement. The Base Prospectus as supplemented constitutes a base prospectus for the purpose of Article 8 of Regulation (EU) 2017/1129, as amended (the "**Prospectus Regulation**").

Application has been made to the AMF in France for approval of this Third Supplement to the Base Prospectus, in its capacity as competent authority under the Prospectus Regulation.

The Issuer declares that, to the best of its knowledge, the information contained in this Third Supplement is in accordance with the facts and the Third Supplement makes no omission likely to affect its import. The Issuer accepts responsibility for the information contained in this Third Supplement.

This Third Supplement has been prepared pursuant to Article 23.1 of the Prospectus Regulation for the purposes of (i) incorporating by reference the information contained in the French language version<sup>1</sup> of the press release of the Issuer dated 25 October 2022 relating to the quarterly information at 30 September 2022 (the "**Vinci Quarterly Information Press Release at 30 September 2022**") and (ii) amending the section entitled "General Information" of the Base Prospectus.
