

**THIRD SUPPLEMENT DATED 7 NOVEMBER 2023
TO THE BASE PROSPECTUS DATED 10 JULY 2023**

This third supplement (the "**Third Supplement**") constitutes a supplement to and must be read in conjunction with the Base Prospectus dated 10 July 2023 granted approval number 23-294 on 10 July 2023 by the *Autorité des marchés financiers* (the "**AMF**") as supplemented by the first supplement dated 4 August 2023 granted approval number 23-347 on 4 August 2023 and the second supplement dated 31 August 2023 granted approval number 23-375 on 31 August 2023 (together, the "**Base Prospectus**") prepared by Vinci (the "**Issuer**") with respect to the Euro 12,000,000,000 Euro Medium Term Note Programme (the "**Programme**"). Terms defined in the Base Prospectus have the same meaning when used in this Third Supplement. The Base Prospectus as supplemented constitutes a base prospectus for the purpose of Article 8 of Regulation (EU) 2017/1129, as amended (the "**Prospectus Regulation**").

Application has been made to the AMF in France for approval of this Third Supplement to the Base Prospectus, in its capacity as competent authority under the Prospectus Regulation.

The Issuer declares that, to the best of its knowledge, the information contained in this Third Supplement is in accordance with the facts and the Third Supplement makes no omission likely to affect its import. The Issuer accepts responsibility for the information contained in this Third Supplement.

This Third Supplement has been prepared pursuant to Article 23.1 of the Prospectus Regulation for the purposes of (i) incorporating by reference the information contained in the French language version¹ of the press release of the Issuer dated 26 October 2023 relating to the quarterly information at 30 September 2023 (the "**Vinci Quarterly Information Press Release at 30 September 2023**") and (ii) amending the section entitled "General Information" of the Base Prospectus.
