## Implementation of the share buyback programme

As part of the implementation of its share buyback programme, VINCI signed a share purchase agreement with an investment services provider on 5<sup>th</sup> May 2025.

According to the agreement, valid from May 6<sup>th</sup> 2025 until June 25<sup>th</sup> 2025 at the latest, VINCI is mandating the investment services provider to purchase VINCI shares on its behalf within the limit of €375 million.

The purchase price cannot exceed the maximum price set by the VINCI Ordinary and Extraordinary Shareholders' Meeting.
